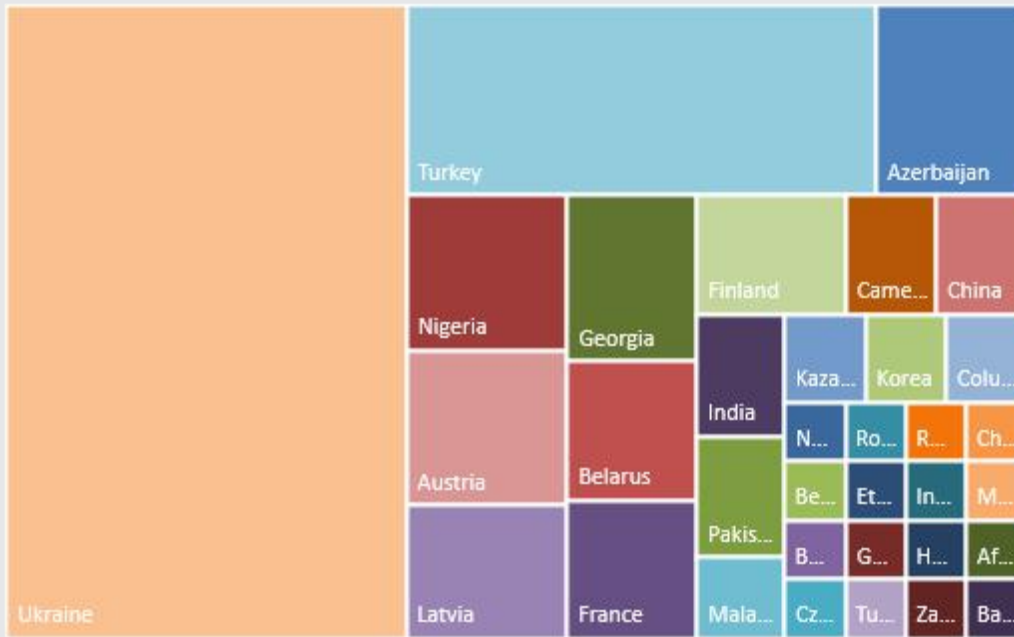

Financial Industry

180 ECTS credits for subjects in Finance field

Fundamentals of Finance, Accounting, Financial and Business Information Systems, Financial Markets and Institutions, Business Finance, Credit Market Participants, Payment Services Market, Finance and Tax Law, Investment Projects Management, Public Institutions Finance, Financial Markets and Institutions Regulation, Insurance, Private Banking, Financial and Real Investments, Financial Risk Management and others.

Studies are completed by the accomplishment of Internship and defense of Bachelor final research project.

The study program includes Law and Financial Law subjects of 24 ECTS credits.

Graduates will be able to work in financial institutions, business organizations, public institutions performing activities of financial managers; to provide financial services as brokers, investment managers, risk governors; as well as will be able to carry out consultation activities or create their own businesses and carry out the financial needs themselves.

ADMISSION PROCEDURE

Application Steps:

1. Fill in the online application form at apply.mruni.eu
2. Load the required documents
3. Secure your registration by paying the application fee
4. Submit your application



REQUIRED DOCUMENTS

1. REQUIRED DOCUMENTS

- Documents required for the undergraduate program: High School Diploma (original or original certificate); Transcript (original or approved actual copy) providing information on the last 4 years of work; YKS results (as of 2018), YGS and / or LYS exams, or previously accepted central examinations
- Documents required for the Masters programs: actual copies of the University transcript and diploma (a candidate must have a University Bachelor's degree or an equivalent first university degree with at least 3 years of study).

Note: Documents must be officially translated in Lithuanian or English.

2. DOCUMENT PROVIDING ENGLISH LANGUAGE PROOF

- Language requirements for undergraduate studies: At least level B1 (TOEFL Paper 477-510, TOEFL IBT 53-64, IELTS 4.5-5.0, PTE level 3)
- Language requirements for Masters Degrees: At least B2 level (TOEFL Paper 513-547, TOEFL IBT 65-78, IELTS 5.5-6.0)

Note: If there is no IELTS or TOEFL, there is the possibility of entering the online English level exam organized by the University. You must select this option when filling the application. There is no additional charge for this test.

IMPROVE YOUR ENGLISH!

Are You interested to study in English, but still do not have a necessary English language skills to do so?

The English Preparatory Program is a program designed for students who want to enter the undergraduate program at Mykolas Romeris University but do not have sufficient English.

Throughout the first year of study, students attend a major undergraduate education program, the training will focus on language studies after completion of the English preparatory courses and at an adequate level. Students will then be able to continue their undergraduate departments.

One-year English Preparatory Program - 1800 euros.



FINANCES AND SCHOLARSHIPS

- Might be granted for Bachelor/Master degree students **for excellent learning outcomes and active involvement in sports, artistic, scientific and social activities**. The MRU Senate Scholarships are granted each semester by the University Senate. The Senate scholarship is granted for one semester and its size is 152€

Erasmus+ Mobility Grants

- All MRU degree-seeking students are eligible to participate in **Erasmus+ mobility for studies or traineeships in other EU countries**, also benefit from all other University international exchange programmes. Depending on a host country the Erasmus+ mobility grants vary:

- For studies (*depending from the destination country*) - 420€ - 520€
- For traineeship (*depending from the destination country*) - 600€ - 700€
